

Conditions Event Participation

1. Definitions

Visitor: every natural person who has registered on the website for the Event by means of the Registration Form.

Confirmation: the admission ticket provided by DevOn to the Visitor that gives the visitor access to the Event.

Event: the (partly) by DevOn organized event, of which name, date and location are stated on the Confirmation or the Ticket.

Registration form: form on the website through which a potential participant registers as a Visitor at the Event.

Tenderer: any natural person who has registered on the website as a participant in the Event by means of a Registration Form, regardless of whether this registration has been confirmed by DevOn.

Registration fee: the amount that the Tenderer owes to DevOn for their registration for the Event.

Location: the location of the event designated by DevOn.

DevOn: DevOn B.V. or an affiliated company that organizes the Event, wheter or not in collaboration with one of more natural or legal persons.

Ticket: the admission ticket provided by DevOn to the Visitor that gives the Visitor access to the Event.

Conditions Event Participation: the Conditions that apply to participation in an Event of DevOn.

2. Registration

- 2.1 A person who wishes to participate in the Event must register for the Event. This must take place using the Registration form on the website. The Registration form must be completed in full.
- 2.2 By completing the Registration form, the Visitor is obliged to pay the Registration fee. The Registration fee must be paid before the start of the Event.
- 2.3 The Tenderer guarantees the correctness of the information provided on the Registration form and the authority of the (representative of) Visitor to register. Any incorrect data or unauthorized registration is at the expense and risk of the Tenderer.
- 2.4 DevOn records the data obtained from the Tenderer in administration kept for that purpose. By registering, the Tendere gives permission for the use and storage of the data provided by him.
- 2.5 Registrations which can not be accepted immediately due to lack of space can be put on a waiting list.

- 2.6 Upon rejection of the Registration by DevOn, any (advance) payments, including the Registration fee, will be refunded.
- 2.7 Registration is only possible by confirmation of the registration by DevOn, after which the Tenderer becomes the Visitor. The Confirmation or the Ticket will be sent by e-mail to the Visitor to the e-mail address provided on the Registration form.
- 2.8 If the Tenderer or Visitor has a complaint about the service, he must notify DevOn immediately and by e-mail, so that the complaint can be rectified if necessary and if possible.

3. Cancellation

- 3.1 If the Tenderer or Visitor wishes to cancel or change a registration, the Registration fee will not be refunded.
- 3.2 If the Tenderer or Visitor wishes to cancel or change the registration due to special circumstances, a request to that effect must be made to DevOn by e-mail. In that case, the Organizer will contact you about the reason and possible follow-up steps.
- 3.3 If the Visitor can not participate in the Event, they are allowed to be replaced free of charge by a colleague, provided the Visitor contacts DevOn and obtains approval for the replacement.

4. Access and stay

- 4.1 During their stay at the Location, the Visitor must behave in accordance with the applicable standards regarding public order, good morals and decency. Furthermore, the Visitor is obliged to behave in accordance with the house rules applied by DevOn relating to the relevant Event. In this connection, the Visitor is also obliged to follow the instructions and instructions given by DevOn.
- 4.2 DevOn is entitled, without stating reasons, to refuse a Visitor access to the Location or to have it removed from the Location if a Visitor does not behave in accordance with the provisions of the previous paragraph of this article or if DevOn otherwise necessary to maintain peace and order during the Event. In that case, the Visitor is not entitled to reimbursement of the Registration Fee..

5. Intellectual property rights

- 5.1 DevOn is entitled to the intellectual property rights related to the Event.
- 5.2 The Visitor is not entitled to reproduce (parts of) the promotional material produced by DevOn or in any other way to infringe intellectual property rights belongin to DevOn, including but not limited to trademark rights, copyrights and

trade name rights.

5.3 DevOn is entitled to make photo and / or film recordings of the Event and the people present there for marketing purposes of DevOn. Stakeholders must tolerate the disclosure of the recordings. Neither DevOn nor any third party to whom DevOn has given permission for such publication and / or multiplication is due to the Visitor for any compensation.

6. Liability

- 6.1 Entering the Location and attending the Event is at the Visitor's own risk. DevOn is not liable for any damage, directly or indirectly suffered by the Visitor, unless there is intent or gross negligence on the part of the Organizer.
- 6.2 The liability of DevOn is in any case (but not limited to) excluded for:
- a. damage as a result of changes in all offers made by DevOn, or by third parties, (program) announcements, announcements or otherwise provided information and quotations regarding the Event;
- b. damage as a result of actions by third parties, including third parties engaged by DevOn such as suppliers, and the persons engaged by these third parties;
- c. damage resulting from the non-compliance by the Visitor with instructions given by DevOn and from non-compliance with general standards of public order, safety and decency;
- d. damage as a result of loss, damage or theft of goods belonging to the Visitor and brought to the Location;
- e. (consequential) damage as a result of changes in the start and end times of the Event;
- f. damage caused in any way by other Visitors of the Event;
- g. damage directly or indirectly to whom or whatever originated as a direct or indirect consequence of any defector any capacity or circumstance in, in or on any movable or immovable property of which DevOn holder, (erf) lessee, tenant or owner or otherwise available to DevOnstate;
- h. consequential damage and indirect (company) damage on the side of Visitor.
- 6.3 The Visitor is liable for and has to take out adequate insurance against any damage of any kind caused by acts or omissions on his part.
- 6.4 The Visitor indemnifies DevOn against all claims that others might make against DevOn in connection with his actions or omissions.

6.5 Any liability of DevOn is limited to the amount that is paid out under the relevant liability insurance of DevOn, on the understanding that in case of lack of cover DevOn's liability is limited to the amount of the amount owed by the Visitor on account of his registration. Registration fee.

7. Force Majeure

DevOn is never liable for any damage suffered by the Visitor as a result of force majeure on the part of DevOn. Force majeure also means any circumstance independent of the will of DevOn, even though it was at the time of the conditions of visit events, (partly) by DevOn organized position of the agreement between DevOn and the Visitor already provide as possibility, which the performance of the contract temporarily or permanently prevented as well as insofar as not already included, war, war violence, civil war, revolt, riots, terror and terror threat, police and / or fire service, strike, transport difficulties, fire, and other serious disturbances DevOn and / or on the Location, weather conditions and for whatever reason non-functioning public transport and the circumstance that an Event due to the fact that the necessary permits for the Event have not been granted or have been withdrawn can not take place or pursuant to a given order of the competent authority must be canceled.

8. Applicability

- 8.1 These Conditions Event Participation apply when participating in an Event, (co-) organized by DevOn.
- 8.2 If and insofar as any provision of the Event Participation Conditions is void or is nullified, the other provisions of these Terms and Conditions Event Participation will remain in full force. In that case, DevOn will determine a new provision to replace the void / voided provision, whereby the purport of the void / voided provision will be taken into account as much as possible.
- 8.3 The conditions of the Event Participation are only valid and binding if they have been expressly agreed in writing. An amendment will have to be signed by the authorized representatives of each of the parties.
- 8.4 DevOn reserves the right to change the Conditions for Event Participation in the interim. The Event Participation Terms and Conditions replace all previous Event Participation Conditions, unless explicitly stated otherwise by DevOn.

9. Applicable law and choice of law

Only Dutch law applies to the Terms and Conditions of Event Participation. Any disputes will be settled by the Dutch court in The Hague.
